IMPORTANT INFORMATION REGARDING YOUR MEMBERSHIP SAVINGS

Effective April 1, 2012, your membership savings account will no longer be considered a transactional account. What does this mean to you? You will no longer have unlimited access to your savings account. Non-transactional accounts are limited to six (6) withdrawals per month, which include debit card transactions, ACH payments, transfers by phone, via internet or by the system to cover insufficient funds. In person withdrawals are unlimited. If you currently have only a savings with Valley and use a debit card, or would exceed the six withdrawals a month, we would ask that you open a checking account (which is considered a transactional account) so your debit card will remain active and we can continue to provide you with the best possible service.
